Buyer is required to have this puppy examined within 72 hours of sale by a veterinarian well experienced in the Bulldog breed. If the veterinarian does not find the puppy to be in good health as outlined in this guarantee and states so in Writing, Buyer must notify the Seller immediately. Seller reserves the right to have the puppy re-examined by our veterinarian at our cost. If diagnosis is confirmed by our veterinarian, Seller will resume possession, if Buyer chooses and be refunded the purchase price of the Bulldog Puppy Only. The Seller shall not pay for any veterinarian bills incurred after the time of sale. The Bulldog puppy is guaranteed against congenital or hereditary defects limited to heart, kidneys and liver that lead to euthanasia or death until the puppy reaches 12 months of age. Cherry Eye, Eye Entropion, is not life threatening and are not covered in this guarantee. Our veterinarian must be notified prior to Euthanasia. A replacement puppy shall be provided at the time of availability. **NO MONEY WILL BE REFUNDED.**

Although a concerted effort is made by Seller to breed sound healthy puppies Buyer should understand that due to the nature of this breed Bulldogs are predisposed to certain medical abnormalities and that a normal Bulldog may have one or more of these conditions during its lifetime. Minor breed related, treatable or correctable condition that may go away or is considered to be a condition which a puppy is likely to outgrow are not covered.

This Bulldog Puppy is sold as Pet Quality Only. No guarantee as to adult size, conformation, dropping of testicles, or suitability of breeding.

There is no guarantee against fleas, worms, coccidia or giardia, hot spots or dermatitis due to their recurring nature. This guarantee is extended to the Original Purchaser Only.
